#### **Why Are You Getting This Letter?**

#### **What Is The Purpose of The Upcoming Hearing?**

The hearing provides landowners and other parties that own property which may be impacted by the Redetermination of Benefits, the opportunity to publicly voice their concerns, opinions or other comments pertaining to the Viewers Report. Benefited landowners should have received a Property Owners Report, showing their properties proposed land classifications and values. The appointed viewers for this joint Redetermination of Benefits will be present at the hearing. The appointed viewers will present their Viewers Report and will be able to give comment during the public comment portion of the upcoming hearing.

#### **What Happens Next?**

Anyone interested in this Final Hearing for the Redetermination of Benefits for Joint Judicial Ditch 10, is asked to attend said hearing. The appointed viewers will present their Viewers Report to the Joint Drainage Authority at the upcoming hearing. If the Joint Drainage Authority finds the Viewers Report acceptable, the possible adoption of the new Viewers Report might be granted. Public comment will be heard during this hearing and will be taken into consideration if changes to the final Viewers Report are needed. Landowners and affected parties are encouraged to work through changes needed before the hearing if possible.
