SLEEPING AND REST ARRANGEMENTS

-Wood and metal full-size and non-full-size cribs need to have a manufactured date of 6/28/11 or later.

-Monthly safety checks must be made on all crib, portable crib or mesh pack & play used or accessible to children.

-Bedding: Clean, separate bedding must be provided for each child in care.

NON-DISCRIMINATION PRACTICES

Provider shall not discriminate in relation to admissions on the basis of race, creed, color, national origin, religion, gender, or disability.

THE CARE OF ILL CHILDREN

The provider shall notify the parent immediately when a child is in care develops any of the following symptoms:

- 1. Underarm temperature of 100 degrees F or over, or an oral temperature of 101 or over
- 2. Vomiting
- 3. Diarrhea
- 4. Rash, other than mild diaper or heat-related rash

Provider is unwilling to accept a child that is: _____

-Provider shall require that a child’s parent notify the provider within 24 hours of the diagnosis of a serious contagious illness or parasitic infestation listed in Chapter 4605 (copy is on hand).

-Provider shall inform a parent of each exposed child the same day the provider is notified a positive diagnosis has been made for any of the illnesses or parasitic infestations listed in Chapter 4605.

-Provider shall notify the Minnesota Department of Health of any suspected case of reportable disease as specified in Chapter 4605.

-When a child has an allergy, the parent must complete and sign the DHS approved Family Child Care Allergy Information Form (DHS-7736). This must be completed before the child is admitted.

-IMMUNIZATION RECORDS must be kept for each child in care in accordance with MN Statutes 121A.15.

-Provider shall obtain written permission and instructions from the child’s parents prior to administering medicine, diapering products, sunscreen lotions, and insect repellants.

-Provider shall obtain and follow written instructions from a licensed physician or dentist prior to administering each prescription medicine. Medicine with the child’s name and current prescription information on the label constitutes instructions.

EMERGENCY, FIRE, AND STORM PLANS

Provider has made emergency, fire and storm plans, keeps a monthly fire and storm drill log, and is required to complete Child Care Emergency Plan using forms provided by the County or State of Minnesota. The Child Care Emergency Plan is to be distributed to parents and is posted in the child care home for parents to access.

TRANSPORTATION PLANS

Each child will be securely fastened in an appropriate passenger restraint system, as described in Rule 9502.0435, Subp. 9

Transportation of Children. A Child Restraint System Training, approved by the Department of Public Safety, must be taken before any transportation can be provided by caregivers. HELPERS AND SUBSTITUTES

“Helper” means a person at least 13 years of age and less than 18 years of age who assists the provider with the care of the children. An adult caregiver must always be present. “Substitute” means an adult at least 18 years of age who assumes the responsibility of the provider. The use of a substitute caregiver must be limited to a cumulative total of not more than 30 days in a 12 month period unless the substitute is also a licensed provider or the provider has the written consent of the agency and of a parent of each child in care. An “Adult Caregiver “ means a person at least 18 years of age that cares assists the provider or substitutes for the provider more than 30 days in a 12 month period. All Substitutes, Helpers and Adult Caregivers need a background study before they care for children.

ALCOHOL & DRUG USE POLICY

MN Statutes 245A.04 Subd. 1 (c) requires provider have a policy that prohibits license holders, employees, subcontractors, and volunteers, when directly responsible for the persons serviced by the program, from abusing prescription medication or being in any manner under the influence of a chemical that impairs the individual’s ability to provider services or care. The license holder must train employees, subcontractors, and volunteers about the program’s drug and alcohol policy.
