ANY PRIOR PERMISSION YOU MAY HAVE HAD IS HEREBY REVOKED AND WITHDRAWN. THIS NOTICE ALSO INVALIDATES ANY PERMISSION TO ENTER OUR PROPERTY GIVEN TO YOU BY A TENANT NOW OR IN THE FUTURE. ANY ATTEMPT BY YOU TO ENTER OUR PREMISES OR PROPERTY WILL BE CONSIDERED A CRIMINAL TRESPASS AND YOU WILL BE PROSECUTED TO THE FULLEST EXTENT OF THE LAW.

State law (Minn. Stat. § 609.605) prohibits any person from intentionally trespassing on the land of another and refusing to depart from that land, without a legal basis, once a demand to depart is made by the lawful possessor or his/her agent. Demand may be spoken or written. This Trespass Notice constitutes a written demand to depart from the land and property immediately. Any violation of this will be considered a criminal trespass and a violation of Minnesota Statute §609.605. Violators may be subject to imprisonment up to 90 (ninety) days or to a payment of up to \$1000, or both. Violators who qualify for enhanced penalties may be subject to imprisonment for up to 365 days or to a payment of up to \$3000, or both.

IT SHALL BE NOTED THAT ON THIS DATE (MONTH/DATE/YEAR), YOU WERE ADVISED OF THE ABOVE STATUTE AND PROVIDED THIS WRITTEN DEMAND TO DEPART FROM THE PREMISES BY THE LAWFUL POSSESSOR AND/OR AGENT OF THE LAWFUL POSSESSOR.
